**VACATION &  
SICK LEAVE**

Calendar and College Year Academic employees accrue vacation and sick leave according to a schedule. Academic year employees do not accrue vacation leave.\*

Part-time Calendar & College year employees hired on or after 7/1/2018 whose professional obligations, as determined by the College President, are primarily other than teaching classes shall be eligible to accrue vacation and sick leave in accordance with the compensation requirements for part-time professional employees as specified below.\*

\*On January 1 of each calendar year, accrued vacation leave credits shall not exceed 40 days; employee will forfeit unused annual leave if not used by last day of the calendar year. Accumulation of sick leave cannot exceed 225 days.

***Part-time Academics hired after July 1, 2024 will earn accruals on the following schedule:***

Part-time calendar year or college year academic employees who teach and who serve on a part-time basis and are initially appointed or commence part-time service on or after July 1, 2024 shall be eligible to accrue vacation leave for each month or major fraction thereof during the term of their professional obligation according to the following schedule:

- 3 credit hours/3 credit hour equivalents to < 6=1/4 day per month
- 6 credit hours/6 credit hour equivalents to < 9=1/2 day per month
- 9 credit hours/9 credit hour equivalents or more=1 day per month

**HOLIDAYS**

Eligible for up to 13 holidays per year **if they fall on a regularly scheduled work day.**

**PAYROLL INFORMATION**

New York State has a two-week lag payroll system. This means that each paycheck pays for the period two-four weeks prior to the date of the check. New employees will not receive their first check for approximately four weeks. Full-time faculty are usually paid over 26 biweekly payroll periods.
